OFFICIAL FEE SCHEDULE

Effective Date: January 1, 2021. This fee schedule supersedes all other fee schedules issued by this office. Federal Grain Inspection Service (FGIS) must approve all fees for official services and OA's will assess only those fees appearing on their current approved fee schedule. **FGIS user fees included in rates.**

Hours:

Fargo, ND: Front office hours, 7:00 a.m. to 4:00 p.m. Monday through Friday except holidays.
Sampling and Inspection at Fargo office: 5:30 a.m. – 1:30 p.m.

Regular Hourly Rates:

Technician and or Sampler \$21.81 per hour.
Inspector \$32.76 per hour.
Additional Labor: \$31.20 per hour.
Rates assessed in ½ hour increments.

Overtime Hourly Rate: 1 ½ time regular hourly rate applied to all hours outside the hours of 7:00 a.m. to 3:00 p.m. for sampling/inspection and Saturday. Sunday and Holidays will be charged at double time.

Holidays include: New Year's Day, Presidents Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve after noon, Christmas Day, and New Year's Eve after noon. Holidays which fall on Saturday will be observed on preceding Friday; those which fall on Sunday will be observed on following Monday.

Standby Rates: Will be charged an applicable hourly rate for delays not caused by the Agency and will apply in one-hour increments.

Minimum Hourly Call out Rates: Minimum 2 hours at applicable hourly rate will apply Monday through Sunday.

Mileage Fees: Mileage will be assessed at the rate of less than or equal to the IRS standard mileage rate and will be prorated when possible.

Travel Time: Will be charged at the applicable hourly rate and prorated when possible.

Finance Charge: 1 ½% per month after 30 days from Statement Date.

Credit Card Fee: Direct pass through of credit card charge from credit card processor, if credit card is used.

Fee Inclusions: Unit fees below include certification, unless otherwise noted, and will note whether the fee includes sampling, grading of factor(s) and/or both.

NDGI reserves the right to determine the number of personnel required to properly provide the service requested.
