OFFICIAL FEE SCHEDULE

Effective Date: February 1, 2023. This fee schedule supersedes all other fee schedules issued by this office. Federal Grain Inspection Service (FGIS) must approve all fees for official services and OA's will assess only those fees appearing on their current approved fee schedule.

FGIS Administrative Tonnage Fees: In addition to all other applicable fees, FGIS administrative tonnage fees for export grain shipments inspected and/or weighed, excluding land carrier shipments to Canada and Mexico, will be assessed at the current per metric ton rate identified in FGIS Directive 9180.74 Service Fees and Billing Codes, Attachment 1. Invoices will identify assessed administrative tonnage fees as separate line items per applicable carrier/unit type.

FGIS Supervision Fees: In addition to all other applicable fees, FGIS supervision fees for domestic U.S. grain shipments inspected and/or weighed, including land carrier shipments to Canada and Mexico, will be assessed at the current per metric ton rate identified in FGIS Directive 9180.74 Service Fees and Billing Codes, Attachment 2. Invoices will identify assessed supervision fees as separate line items per applicable carrier/unit type.

Regular Hours: 7:00 a.m. to 3:00 p.m. Monday through Friday excluding holidays. Time may be prorated when possible. **All requests for service will be honored on a first call first service basis.**

Regular Hourly Rates: (4-hour minimum applies unless stated otherwise)

Sampler, Technician, Weigher, Other & Cancellation: \$31.00 per hour.

Inspector Rate: \$41.00 per hour.

All services during regular hours must be cancelled a minimum of 6 hours prior to start, otherwise the 4-hour minimum charge will apply. All hours are per person and assessed in ¼ hour increments. ANY cancellations made during non-regular hours will have applicable minimum charge applied.

Overtime Hourly Rate: (4-Hour minimum applies to ALL sampling) One and one half (1 ½) times applicable hourly rate applies to all hours outside regular hours and Saturday. (Unless Holiday rate applies.)

Holiday & Sunday Hourly Rate: (4-Hour minimum applies to ALL sampling) Two times applicable hourly rate applies to all hours worked on a Holiday and Sunday.

Stand-by Rate: Any stand-by time in excess of one hour will have an additional \$8.00 per hour added to the appropriate hourly rate.

On-Call: On call charges will be applied for requests to hold personnel outside regular business hours. Elevator must establish a start time by 3:00 pm regular business hours. If work is not performed at established time there will be a 4-hour minimum charge, at applicable hourly rate, for each employee that was held for that service.

Holidays Include: New Year's Day, Presidents Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day. Holidays which fall on Saturday will be observed on preceding Friday; those which fall on Sunday will be observed on following Monday.

Mileage Fees: Mileage will be assessed at a rate of less than or equal to the IRS standard mileage rate and will be prorated when possible.

Travel Time: Will be charged at the applicable hourly rate and prorated when possible.

Sample Pick-up/delivery: Applicant will be charged appropriate hourly rate and mileage. (Prorated where applicable).

Finance Charge: 1 1/2% per month after 30 days from statement date.

Credit Card Fee: Direct pass through of credit card charge from credit card processor, if credit card is used.

Fee Inclusions: Unit fees below include certification, unless otherwise noted, and will note whether the fee includes sampling, grading of factor(s) and/or both.

NDGI reserves the right to determine the number of personnel required to properly Provide the service requested.

Minimum Fee(s): Container, Rail & Truck sampling request must average a minimum of 2 units sampled per hour otherwise an additional \$11.00 will be applied per hour. Time for averaging will be calculated from NDGI office until returning back to NDGI office.

Checktesting Charges/On-Site Lab Information:

Approval of DT Samplers & Checktesting \$62.50 per hour per person plus mileage and travel time at applicable rate. All customers are responsible for the charges of maintaining equipment.

All on-site labs will be built, maintained and equipped by the applicant.

NDGI will not guarantee the availability of an inspector for on-site grading unless there is a minimum of 100 cars being loaded in a 24-hour period. If an inspector is available, we will provide one at the applicable rates.

Sealing: (Hourly and mileage charges will apply when applicable.)

Plastic Seals (per seal)	\$1.45
Cable Seals (per seal)	\$2.40
- A picture of every Railcar ID and each seal is taken and stored at NDGI for 30 days for cable seals.	
- An extra person will be sent out solely to take pictures and charged at the Additional Labor Rate if cable seals are needed.	
- It will be the responsibility of the applicant to notify NDGI when cable seals are needed.	
Certification – applicants request seal numbers recorded on certificate.....	\$2.40
